#### Introduction about DOCTORS FOR YOU-

Doctors For You (DFY) is a registered society, registered under the Societies Registration Act 1860 Section 21 having registration no. F-56886(Mum). DFY is a pan India humanitarian organization with international presence and is working in various disaster hit zones since last 14 years.

DFY focuses on providing medical care to the vulnerable communities during crisis and non-crisis situation, emergency medical aid to people affected by natural disaster, conflicts and epidemics.

The work of DFY is guided by humanitarian principles of humanity, impartiality, and neutrality. It offers services and assistance to people based on need, irrespective of race, class, caste, religion and gender.

PHC Maharashtra – Chopda hospital is located at Jalgoan village, Maharashtra and it has Maternity ward, childcare unit and labor Room. Also, it includes OPD, General Ward, Vaccination work.

India contributes to 20% of global maternal deaths. Around 56,000 women die every year in the country due to pregnancy or pregnancy related causes. Maternal Mortality Ratio (MMR) of India is 113/100,000 as per National Sample Registration System (SRS) data 2016-18. Pregnancy-related complications are high in child brides (among girls between 15-19 years of age). There Goal is to Reduce the maternal deaths as far as possible. The direct causes of maternal deaths are preventable and treatable.

#### **Termination:**

It is the responsibility of the successful bidder to start the work within the specified period of 10 days.
