Maternal Mortality Ratio (MMR) of India is 113/100,000 as per National Sample Registration System (SRS) data 2016-18. Pregnancy-related complications are high in child brides (among girls between 15-19 years of age). There Goal is to Reduce the maternal deaths as far as possible. The direct causes of maternal deaths are preventable and treatable.

## SCOPE OF WORK

### Remarks-

Final issuance of payments to be done on the basis of submission of proofs of the quality/quantity and make of the material.

**Project Reward-** The contract will be awarded by the governing body of Doctors for you, whose decision shall be final and binding to all parties.

**Delivery Period-** The Delivery period for the assimilating the Equipment to execute the installation shall be 20 days from the award of the contract to the successful bidder.

### Eligibility Criteria:

1. The Bidder can be an Individual/Partnership firm/ Proprietorship firm / Limited or a Private Limited Company registered under the Indian Companies Act, 1956, or any Public or private establishment or a registered contractor. Consortiums or Joint ventures of companies and/or individuals are also allowed to participate.
2. The bid shall be awarded to the bidder with the highest turnover in the last three years and should have a holding capacity of at least 60 days.
3. The bidder shall have a positive net worth in the last submitted financial return of the bidding company

### Acceptance of bid:-

The decision of the governing bidder shall be final and binding on the bidders. Inviting Authority does not pledge itself to accept the lowest or any bid. The governing body of DFY reserves the right to reject any or all offers without assigning any reasons.

Please note that Inviting Authority requires complete turnkey solutions. Hence, bidders are required to include all infrastructure work to be included in the scope for construction of the multi-specialty hospital. Figures should provide detailed drawing and layouts of the work.

- a. Incomplete and Conditional offers will not be accepted.
- b. The successful bidder shall have to enter into an agreement with Doctors For You as per the provisions of MoU mentioning scope of work, timelines schedules, safety instructions and statutory compliances. The provisions of the MoU are binding on the selected bidder and in case of any deviation from the same, will lead to penalty or fine
- c. The successful bidder shall raise invoices on a monthly basis and after verification from the appointed nodal officer the payment shall be issued after deducting statutory taxes etc.
- d. Mobilization period: - The successful bidder will be given 15 days to mobilize manpower and material and start the said operations at the site. If a successful bidder fails to execute the work within a given time, the work order issued can be canceled and the work may be assigned to other qualified bidders completely or on sharing of unit basis.
- e. Professional excellence: - It is the sole responsibility of the Bidder to provide operations and management services. It is expected that the Bidder/Group company shall provide their services of highest professional excellence. The Bidders should have the highest integrity and ethics towards their profession.

### Payment Schedule:

The bidder shall raise invoice as per the provisions of the MoU and shall submit to the nodal officer and Governing body of for verification. Post verification the payments shall be issued by the authority. On verification of material Quality and Quantity 30% payment will be released, on Delivery of the same next 50% and after fulfillment of all the work the remaining 20% will be released

### Termination:

It is the responsibility of the successful bidder to start the work within the specified period of 10 days. The governing body of DFY can terminate the contract on the basis of specific grounds mentioned in the MoU. In case if the successful bidder fails to start the work within 10 days, unless allowed by the competent authority on specific grounds or deviates from the provisions of MoU, the

governing body of Doctors For You shall be terminated and the payment due to him will be forfeited. Further, the retention money withheld earlier will also be forfeited

**Committees of the Competent Authority:**

The governing body of DFY will appoint an internal audit team, for the review of the work done and to provide feedbacks based on which meeting will be held with bidder in order to improve the work to a satisfactory level.

**Dispute Resolution:**

In case of any disputes, the matter shall be referred to the governing body of DFY, the decision of which will be final and binding on the bidder.

**Variation**

In case of any additional work apart from MoU that is required to be done during the process, the governing body of DFY will be the final decision-making authority
