## 1. Introduction

- I. **Hindustan Latex Family Planning Promotion Trust (HLFPPT)**, a trust promoted by HLL Lifecare Limited and registered under the Travancore-Cochi Literary, Scientific Charitable Societies “HLFPPT”, hereinafter called as “Principal Recipient”, for the implementing “SSHAKTI (Strategizing & Strengthening HIV/AIDS and TB Initiative)” Grant (GC7), under grant agreement (IND-C-HLFPPT) from 1st April 2024 to 31st March 2027.
- II. **Doctors For You (DFY)**, New Delhi, India (a not-for-profit Company Registered under the Societies Registration Act 1860 Section 21 having registration no. F-56886(Mum). DFY is a pan India humanitarian organization with international presence and is working in various disaster hit zones since last 18 years. DFY focuses on providing medical care to the vulnerable communities during crisis and non-crisis situation, emergency medical aid to people affected by natural disaster, conflicts and epidemics. We are also committed to reducing disaster risk to human society by delivering trainings and capacity development in emergency preparedness and response. The work of DFY is guided by humanitarian principles of humanity, impartiality, and neutrality. It offers services and assistance to people based on need, irrespective of race, class, caste, religion and gender.
- III. DFY invites proposal from private sector health care system in India including Private hospitals/trust hospitals/NGOs/poly clinics / Nursing Homes which are already providing treatment to the TB patients.
- IV. The **Purpose** of this initiative under NTEP is to create hubs and spokes within the private sector as the nearest facilities for the TB patients who are seeking care in the private health sector and for ensuring quality of services as per Standards for TB Care in India especially for DRTB diagnostic-care cascade including public health action initiating with private provider engagement to notification, sample collection and transportation, linkages for TB diagnostic and drugs, comorbidity screening, treatment adherence support and counselling, patient and provider incentives, adverse drug reaction reporting, risk assessment of TB patients for differentiated care, contact investigation and thus following the standards of care. The **Objective** of this EOI is for establishing Hub and Spoke for DRTB care within five states of India.
  - a) Mapping potential facilities (Private hospitals/trust hospitals/NGOs/poly clinics / Nursing Homes), which are already providing treatment to the TB patients.
  - b) Establishment of Hubs and Spokes center through technical support by DFY.
- V. Interested service provider will be approached and assessed the health facility for establishment of DRTB care center (OPD/ IPD based). Out of those selected service provider, will be provided technical assistance to the establish Hubs and Spokes for providing DRTB care. Technical assistance shall be done

through in-person visits and through workshops/CMEs on regular includes training of the human resources ( medical and paramedical staff), those who will manage DRTB center, Hands-on training for the workflow mechanism, streamlining TB support, service deliveries, and ensuring availability of DRTB drugs (Bedaquiline and Delamanid) from NTEP , identification of latent TB infection among contacts and initiation of TB preventive therapy and regular reporting and recording. DFY shall facilitate private provider engagement package for DRTB services, to ensure effective and long terms relationship is built up between private providers and NTEP.

- VI. Detailed description of the services are provided in the Section: Terms of Reference.
- VII. DFY shall receive applications of Expressions of interest from Service Providers who apply via email and hardcopy on [procurement.gfund@doctorsforyou.org](mailto:procurement.gfund@doctorsforyou.org) by **27-03-2025**
- VIII. All Eols shall be prepared and submitted by Service Providers in accordance with the instructions given in this Section on or before the date and time specified herein.
- IX. DFY shall shortlist eligible and qualified Service Providers for awarding the Scheme through an open competitive process.

## **2. Brief Description of Selection Process**

- 2.1 DFY has adopted the following process for selection and award of Scheme(s) to Service Providers:
- 2.2 The interested Applicants shall submit their Applications against this Request for Expression of Interest in accordance with the instructions given in this EOI Document. DFY shall evaluate Applications received up to due date and time and shortlist all eligible and qualified Service Providers.
- 2.3 Subsequently, DFY shall verify the compliance status of the service provider and those service providers found to be eligible and qualified during first stage, shall be invited to participate in a discussion cum selection meeting, on the basis of which, the scheme will be awarded to the qualifying service provider.

## **3. Eligibility & Qualification of Applicants**

- 3.1 The eligibility and qualification of the Applicants will be assessed on the basis of eligibility criteria enumerated as per **point no. 10 & 11**.

## **4. Right to accept or reject any or all Applications:**

- 4.1 Notwithstanding anything contained in this EOI Document, DFY reserves the right to accept or reject any Application and to annul the selection process and reject all Applications, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof. In the event that the DFY rejects or annuls all the Applications, it may, in its discretion, invite fresh Applications.
- 4.2 DFY reserves the right to verify all statements, information and documents submitted by the Applicant in response to the EOI.

## **5. Amendment of EOI**

- 5.1** At any time prior to the deadline for submission of Application, DFY may, for any reason, whether at its own initiative or in response to clarifications requested by an Applicant, modify the EOI by the issuance of Addendum. It is further clarified that the configuration and the responsibilities, terms and condition of the scheme may be changed by the DFY and it shall be binding on the Applicants.
- 5.2** Any Addendum / clarifications thus issued will be made available and can be downloaded from the website and portal as mentioned above.
- 5.3** In order to provide the Applicants a reasonable time for taking an Addendum into account, or for any other reason, DFY may, in its sole discretion, extend the Application Due Date.

## **6. Submission of Application:**

- 6.1 The Applicant shall provide all the information sought under this EOI. DFY will evaluate only those Applications that are received in the required formats and complete in all respects. Incomplete and /or conditional Applications shall be liable to rejection.

  - 6.13 DFY, at its sole discretion, may extend the due date & time for submission of Application.
  - 6.14 Late Applications received after the date and time mentioned in this document shall not be accepted.
  - 6.15 No modifications / substitutions / withdrawal shall be accepted after the due date.

## **7. Opening and Evaluation of Applications**

- 7.1 DFY or its authorized personnel shall download all the EOI Applications received up to due date and time for submission of Applications.
- 7.2 DFY or its authorized personnel, in consultation with PR will subsequently examine and evaluate Applications in accordance with the provisions set out in the Eligibility Criteria
- 7.3 DFY reserves the right not to proceed with the selection process at any time without notice or liability and to reject any or all Application(s) without assigning any reasons.

## 8. Shortlisting of Applications and Notification

- 8.1 After the evaluation of Applications, DFY after consultation with PR would announce a list of shortlisted Applicants who will be eligible for selection meeting to all the shortlisted applicants via email. The Authority will not entertain any query or clarification from Applicants who fail to qualify.

## 9. Scope of Work

- 9.1 A mutual understanding will be reached between Hubs, spokes and NTEP wherein hubs will manage OPD based along with inpatient DRTB cases while spokes will refer all the difficult to treat cases to hubs. Once inpatient treatment is completed patients will be encouraged to continue their OPD based DRTB treatment either at the spoke or any other DRTB facility close to patient's residence unless the patient is unwilling to do so.
- 9.2 **Patient Flow mechanism-** Sample Collection and Transportation Norms. Any presumptive DRTB patient advised for DST (Drug Susceptibility Testing) by a private provider will have their sample collected at the designated site, either a private/public lab or a diagnostic Hub, based on the patient's preference and availability. The sample will be labelled to ensure proper identification and tracking. After collection, the sample will be transported under standardized conditions to the assigned laboratory for DST, adhering to biosafety and cold chain norms to maintain sample integrity.

If the patient is diagnosed with H mono/poly resistance or RR/MDR, they will be initiated on treatment after a pre-treatment evaluation at the Hub. In cases where the patient is eligible for outpatient-based DRTB treatment, the private provider will refer them to a spoke facility for continued care.

For patients who are debilitated, or diagnosed with pre-XDR or XDR based on second-line LPA results, or are eligible for inpatient treatment, services will be initiated at the Hub. The patient will be referred to a spoke facility once medically stabilized, with all relevant clinical and diagnostic records transferred through the hub-and-spoke system for continuity of care.

- 9.3 **Public Health Action:**  
**Comorbidity testing:**

**A. HIV Testing:**

- The health facility shall ensure all DRTB patients diagnosed in the private sector are with known HIV status. For this, the health facility shall establish referral linkages for HIV testing at public / private facility.
- For patients with the test result is reactive on screening, the health facility shall be responsible to establish effective linkages between patients and the nearest ICTC for confirmatory testing. If found HIV positive the patient shall be linked to the nearest ART center for DRTB HIV management, as required.

**B. Blood sugar testing for Diabetes Mellitus:**

- The health facility shall ensure all DRTB patients diagnosed in the private sector are tested for diabetes. For this, the health facility shall establish linkages for testing at public / private facility.
- For patients who are found diabetic, the health facility shall effectively manage the diabetes.

**C. Universal Drug Susceptibility Testing (UDST):**

- The health facility will establish linkages for UDST services (NAAT, line probe assay, culture & DST at notified public sector labs / linked private labs (as applicable) as per the prevailing algorithm.
- This will include both first and second line DST.
- **Exclusive Drug resistant TB management:** The health facility shall ensure following services under DR TB care
- Counselling of DR-TB patients for treatment initiation
- Linkages for investigations for pre- treatment evaluation
- Linkages for free treatment at private or public health facility, as per convenience of patients (reducing the out-of-pocket expenditure)
- Contacts investigation and TB preventive treatment as per the PMTPT (Programmatic management of TB Preventive Treatment) guidelines.
- Identification, referral and linkages for management of adverse drug reaction.
- Treatment adherence support
- Follow-up for clinical examination and sputum examination
- Reporting of treatment outcomes

**D. Treatment adherence support and counselling:**

Health facility needs to ensure –

- Patient home visit at the start of treatment and follow up visits as per NTEP guidelines or STCI with the coordination with NTEP staff.
- Counselling of patients and their families on – nutrition, de-addiction, stigma/discrimination/, treatment compliance, adverse drug reaction, hygiene, and prevention of disease spread
- Use of Digital Adherence Tools wherever applicable
- Identify adverse drug reaction and ensure, it gets managed effectively
- Risk assessment of TB patients for differentiated care:
- The health facility may facilitate risk assessment of patients at regular interval and facilitate linkages for appropriate management.
- Update treatment outcome of these patients
- All information related to the patient notified needs to be entered in Nikshay regularly.

**E. Patient and provider incentive:**

- The health facility shall generate awareness on incentives to patients (Nikshay Poshan Yojana, Tribal support scheme, Treatment supporter's honorarium and Incentives for notification and outcomes and collect the bank account details with necessary supporting documents as per NTEP guidelines from patients and update on Nikshay.



- DFY shall inform private providers on various incentives (informant, notification, treatment support, outcome) and collect the bank account details with necessary supporting documents as per NTEP guidelines and update on Nikshay.
- The DFY may assist NTEP in releasing incentives to patients and private providers in timely manner.

**9.4 Contact Investigation: Contact Screening and TBI Treatment Protocol :** contact tracing, sample collection, transportation, and TB preventive treatment (TPT) activities will be carried out by integrating the National TB Elimination Program (NTEP) staff and the existing healthcare infrastructure in the respective state

- If the patient is willing to take FDC from NTEP, they can do so through this facility also. In that case facility will keep the record of all such patients and drugs dispensed.
- The evidence based regimen including Bedaquiline and Delamanid containing treatment will be provided by NTEP through ni-kshay aushadhi, a supply chain management platform and facility cannot charge the patients for these Medicines, without any cost charges for it. Update and maintain patient wise data in ni-kshay as per PMDT guidelines.
- When the DRTB patient is diagnosed, the health facility notifies on ni-kshay and the required consumables including the ATT medicines will be indented on the ni-kshay aushadhi platform. This NTEP staff would facilitate this transactional data on real time for the patient centric care. Patient wise boxes/drugs will be sent to the treating physician in the hubs and spokes by NTEP. Since, Hubs will cater to a large number of the patients thus a buffer of patient boxes will also be given.
- All the drugs obtained from NTEP will be replenished once their utilization/ consumption report is submitted by the facility and is certified by DTO.
- During any time, if the unfavorable outcome or discontinuation of the regimen due to any reason occurs, patient wise boxes/ ATT , which are not fully utilized will be returned to NTEP.
- Hubs will provide the treatment to DRTB patient till the time patient is admitted in IPD and if patient chooses to continue the rest of the treatment through hub. In case patient chooses to take the treatment from Spokes once discharged from hub, hub will provide treatment for 7 days to ensure any missed doses till the time treatment is initiated at the spokes again.
- Whenever any requirement for hospitalization related to TB or TB treatment, occurs the patient will be referred to Hub for the same and will be given 5-7 days of the medicines till the time patient resumes the treatment from Spokes.
- All the mechanism for patient flow will be followed as per the currently followed in the PMDT guidelines in the public system considering Nodal DRTB centers as Hubs and District DRTB centers as spokes.
- DFY personnel will facilitate the linkage between District NTEP, Hubs & spokes for all the activities, maintaining the stock, preparing utilization, notification of the cases, pre-treatment evaluation and including the public health actions, post treatment follow up
- DRTB drugs will be issued by the name of patient to the respective hub or spoke facility but respective Hubs and Spokes will follow up each case to ensure treatment uptake and utilization of DRTB drugs, adherence, and any reported ADRs.

## 10. Preliminary Evaluation Criteria

From the time the Proposals are opened to the time the Contract is awarded, the service provider should not contact DFY on any matter related to its Technical Proposal. Any effort by service provider to influence DFY in the examination, evaluation, ranking of Proposals, and recommendation for award of Contract may result in the rejection of the 'Service Provider' Proposal.

- I. The service provider should have registered office in India (Registration Certificate to be provided) **for Hubs and Spokes**.
  - a. If service provider is a Nursing home, then registration under State Nursing home act is required.
  - b. If trust/charitable hospital- Registration no. of trust or registration with charity commissioner is required.
  - c. Other relevant registrations if any, to be produced as per the regulations.
- II. The service provider should be registered under GST, if applicable. In case of non-applicability of GST, an undertaking is to be submitted by the service provider. Copy of PAN, GST registration, if applicable, should be submitted **for Hubs and Spokes**.
- III. An undertaking (self-certificate) that the service provider hasn't been blacklisted by a central / state Government institution and there has been no litigation with any government department on account of similar services **for Hubs and Spokes**.
- IV. Proof that service provider has functional TB management facility to cater the requirements mentioned in the Scope of Work **for Hubs and spokes**
- V. The service provider should have all other relevant licenses from state bodies/other relevant authorities required to provide services as per the scope of work mentioned in this document **for Hubs and spokes**.
- VI. The service provider should have collection centers/ lab facilities, mentioned in the scope of work to cater to the requirements **for Hubs**.
- VII. The service provider should have qualified medical personnel, adequate infrastructure and equipment to perform as per the scope of work mentioned in this document **for Hubs**.
